CHANGE TO ADDITIONAL PREMIUM AREAS

We are writing to give Members notice of changes to the Association's Additional Premium (AP) Areas, as follows:

The following area is **ADDED**:-

Cabo Delgado

The waters within 50 nautical miles of Mozambique and Tanzania enclosed by the following boundaries:

- a) To the north, from Mnazi Bay at $10^{\circ}19.6$ 'S, $40^{\circ}18.9$ 'E to high seas point at $9^{\circ}50.7$ 'S, $41^{\circ}7.6$ 'E.
- b) To the south, from Baía do Lúrio at $13^{\circ}30$ 'S, $40^{\circ}31.6$ 'E to high seas point $13^{\circ}30$ 'S, $41^{\circ}28.8$ 'E.

The following areas are AMENDED:-

Indian Ocean, Gulf of Aden and Southern Red Sea

The waters enclosed by the following boundaries:

- a) On the north-west, by the Red Sea, south of Latitude 15° N
- b) on the northeast, from the Yemen border at 16°38.5'N, 53°6.5'E to high seas point 14°55'N, 53°50'E
- c) on the east, by a line from high seas point 14°55'N, 53°50'E to high seas point 10°48'N, 60°15'E, thence to high seas point 6°45'S, 48°45'E
- d) and on the southwest, by the Somalia border at 1°40'S, 41°34'E, to high seas point 6°45'S, 48°45'E

excepting coastal waters of adjoining territories up to 12 nautical miles offshore unless otherwise provided.



Persian or Arabian Gulf

Persian or Arabian Gulf and adjacent waters including the Gulf of Oman and waters west of the line from Oman's territorial limit off Cape al-Hadd at 22°42.5'N, 59°54.5'E northeast to the Iran-Pakistan border at 25°10.5'N, 61°37.5'E excepting coastal waters of adjoining territories up to 12 nautical miles offshore unless otherwise provided.

Oman

Musandam Governorate

With effect from **00.01 hrs. GMT on 15 May 2021**, and until further notice, the ports, places, countries, zones or areas (whether of land or sea) listed below shall be Additional Premium Areas pursuant to Rule 19 (Note: The **bold** headings are for ease of reference only).

Members are also advised to review the map on page 4 of this Circular for clarification. Note that the map is illustrative only, and does not take individual country territorial limits into account.

Indian Ocean, Gulf of Aden and Southern Red Sea

The waters enclosed by the following boundaries:

On the north-west, by the Red Sea, south of Latitude 15° N

On the northeast, from the Yemen border at 16°38.5'N, 53°6.5'E to high seas point 14°55'N, 53°50'E

On the east, by a line from high seas point 14°55'N, 53°50'E to high seas point 10°48'N, 60°15'E, thence to high seas point 6°45'S, 48°45'E

And on the southwest, by the Somalia border at 1°40'S, 41°34'E, to high seas point 6°45'S, 48°45'E

excepting coastal waters of adjoining territories up to 12 nautical miles offshore unless otherwise provided.

Cabo Delgado – the waters within 50 nautical miles of Mozambique and Tanzania enclosed by the following boundaries:

To the north, from Mnazi Bay at $10^{\circ}19.6$ 'S, $40^{\circ}18.9$ 'E to high seas point at $9^{\circ}50.7$ 'S, $41^{\circ}7.6$ 'E. To the south, from Baía do Lúrio at $13^{\circ}30$ 'S, $40^{\circ}31.6$ 'E to high seas point $13^{\circ}30$ 'S, $41^{\circ}28.8$ 'E.

Gulf of Guinea, but only in respect of the area enclosed by: On the west, from the coast of Togo 6° 06'45'' N, 1°12'E, south to High seas point 0° 40'S, 3° 00' E And then east to Cape Lopez Peninsula, Gabon 0°40'S, 8° 42'E.

Israel Lebanon Oman (Musandam Governorate)

Persian or Arabian Gulf and adjacent waters including the Gulf of Oman and waters west of the line from Oman's territorial limit off Cape al-Hadd at 22°42.5'N, 59°54.5'E northeast to the Iran-Pakistan border at 25°10.5'N, 61°37.5'E excepting coastal waters of adjoining territories up to 12 nautical miles offshore unless otherwise provided.

Saudi Arabia (Gulf Coast) Saudi Arabia (Red Sea Coast) excluding transits Syria United Arab Emirates Yemen

South America

Venezuela

All areas above excepting coastal waters of adjoining territories up to 12 nautical miles offshore unless otherwise provided, and subject to the conditions that the Entered Ship does not approach within 50 nautical miles of the north coast of Somalia. or within 100 nautical miles of the Socotra Archipelago, or within 200 nautical miles of the east coast of Somalia.

The named countries shall include their coastal waters up to 12 nautical miles offshore, unless specifically varied above. The named ports shall include all facilities/terminals within areas controlled by the relevant port authority/ies (as or may be more precisely defined) including offshore terminals/facilities and all waters within 12 nautical miles of such but not exceeding 12 nautical miles offshore unless specifically stated.

Members' attention is drawn to the terms of Rule 29 (Additional Premiums). The Owner of an Entered Ship is required to give the Association written notice before an Entered Ship proceeds to an AP Area. If notice is not given as required, the Entered Ship has no cover while in the AP Area. The notices required under Rule 29 should be given to the Managers.

The Managers would be pleased to answer any questions that may arise.
